The Master of Science in Management (<https://business.gmu.edu/programs/graduate-degree-programs/masters-management/>) is a highly customizable, multidisciplinary program combining core, business fundamentals courses with business and non-business areas of concentration via existing graduate certificate programs. Students complete core coursework with a graduate certificate program, resulting in a highly, flexible master's program aligned with professional interests and career ambitions. The program has part-time and full-time options, appealing to recent graduates, as well as mid- and late-career professionals.

## Accelerated Master's

### Bachelor's Degree (any)/Management, Accelerated MS

#### Overview

The BAM pathway will provide the opportunity for prospective undergraduate students to further their education by offering a specialized accelerated program that allows them to pair fundamental business management skills with interdisciplinary coursework tailored to the student's career interests.

Undergraduates may be admitted to a Bachelor's/Accelerated Master's program (BAM) and obtain a BS/BA in a chosen major and an MS in Management (MSM) in an accelerated time frame after satisfactory completion of a minimum of 141 credits.

#### BAM-MS Management Pathway Admission Requirements

Applicants to all graduate programs at George Mason University must meet the admission standards and application requirements for graduate study as specified in Graduate Admissions Policies and Bachelor's/Accelerated Master's Degree Policies. Students will be considered for admission into the BAM pathway after completion of a minimum of 60 credits, and additional unit-specific criteria. Full admission requirements can be viewed at the Costello College of Business website. (<https://business.gmu.edu/>)

Students who are accepted into the BAM pathway will be allowed to register for graduate level courses after successful completion of a minimum of 75 undergraduate credits and all course-specific pre-requisites.

#### Accelerated Master's Admission Requirements

Students in the BAM pathway will be admitted to the MS in Management program if they have met the unit-specific criteria found here and as verified on the Bachelor's/Accelerated Master's Transition form.
