### Admissions

- In addition to standard requirements through the university's online application, requirements for this program include:
- Transcript audit that indicates: Bachelor of Music or its equivalent, minimum cumulative G.P.A. of 3.0 (Endorsement Worksheet)
- Official copy of Praxis Core Academic Skills for Educators Test (or equivalency)<sup>1</sup>
- One page professional goals statement submitted with application
- Upon application review by music education faculty, the successful applicant will be invited to an interview and music skills proficiency exam.

Coursework completed at other institutions will not be considered for transfer into this graduate certificate program. Applicants who believe they have met requirements for a license are encouraged to apply directly to the Virginia Department of Education (VDOE). ### Internship

Upon completion of coursework the candidate must complete a student teaching internship at the elementary and secondary levels in a program-approved public or private school (6 credits). Prior to being permitted to student teach, the candidate must complete and pass the VCLA, the Praxis Subject Assessment (Music Content Knowledge-5113)<sup>1</sup>, and the MTEC Competency Check<sup>2</sup>.
